LIST OF AMENDMENTS MADE BY FEDERAL ELECTION CAMPAIGN ACT  
AMENDMENTS OF 1976-Public Law 94-283

The attached list identifies each amendment made by the Federal Election Campaign Act Amendments of 1976, Public Law 94-283, with a tag line and also identifies the section of the "Act" which is amended or repealed, and the section of the United States Code which is amended or repealed and the section of the Public Law 94-283 which effects these changes. "Act" refers to the Federal Election Campaign Act of 1971, as amended by the Federal Election Campaign Act Amendments of 1974 and the Federal Election Campaign Act Amendments of 1976.

The term "technical amendment" indicates an amendment which is not substantive in nature, but which changes cross-references to other sections of law, deletes a word such as "and", or makes similar non substantive changes.

The list is intended only as a research tool to expedite finding the sections of the law which have been changed and in all cases it is recommended that the text of the law be consulted.
